DLC

In DLC infrastructure report, the CID was the only source of funding. A position statement draft letter in response to the report was presented. During discussion it was stated that infrastructure is not just a downtown problem, it is a city wide problem. It was also suggested that at the next DLC meeting a motion should be made to remove the funding section from them report.

The letter includes the CID petition that states that the CID would not be taking over city services and the petition was very specific about what service the CID would provide. Waigandt motioned to send the letter with the amendment that it should include that this is a city wide problem, not just a downtown problem and should not be funded solely through downtown sources; Mendenhall seconded and none were opposed.

Kelley stated that she would invite Mike Matthes to the next board meeting to discuss infrastructure.

Search/Executive Committee

Twenty-two applicants have been narrowed down and will be conducting interviews next week. A special board meeting will be set up for the final candidates to interview with all of the board members.
